

# **Uniform Policy**

### **Objective:**

*Solaren Risk Management, LLP* strives to maintain a workplace environment that is well functioning and free from unnecessary distractions and annoyances. As part of that effort, the company requires employees to maintain a neat and clean appearance that is appropriate for the workplace setting and for the work being performed. To that end, *Solaren Risk Management, LLP* Directors may determine and enforce guidelines for workplace-appropriate attire and grooming for their professional mission; guidelines may limit natural or artificial scents that could be distracting or annoying to others.

#### Procedures

All *Solaren Risk Management, LLP* staff members are expected to present a professional image to customers, visitors and the public.

Supervisors should communicate any workplace specific attire and grooming guidelines to staff members during new-hire orientation and evaluation periods. Any questions about the department's guidelines for attire should be discussed with the immediate supervisor.

Any staff member who does not meet the attire or grooming standards set by his or her department will be subject to corrective action.

## Grooming

All employees and contractors shall be clean and properly groomed when reporting for duty and while on duty. Employees and contractors will maintain uniforms, insignias, accessories, and equipment in a serviceable manner, and all items shall be kept clean and uniforms wrinkle free.

Beards, Goatees, Mustaches must be neatly trimmed and not exceed the edge of the lips. All law enforcement will be limited to either a mustache or a tightly kept goatee.



Hair and or wigs must be natural in color and shall be kept clean, neat, and styled to present a neat appearance. For females, hair may be worn in an "up" style so as not to interfere with the wearing of the uniform or use of equipment.

No decorations shall be worn in the hair, and items used to hold the hair in place shall be concealed as much as possible and shall be of a color and style that blend with the hair.

Body- piercing jewelry shall not be visible when the officer is in uniform. This includes but is not limited to lips, tongue, eyebrows, cheeks, and other parts of the face. In the same manner, hickeys, "love bites," or "passion marks" shall not visible when the officer is in uniform. This is for the safety of the officer as well as the professional image of *Solaren Risk Management, LLP*.

Tattoos are allowed, but taste should be considered when wearing the uniform. If the tattoo is deemed offensive or distasteful it will need to be covered while working for *Solaren Risk Management, LLP*. Employees and contractors are not allowed to have facial tattoos.

\*All equipment, shirts, and badges are to be turned in prior to resigning employment. If an employee or contractor fails to turn in all items issued to them the cost therein will be deducted from their final pay check.

#### Addressing workplace attire and hygiene problems

Violations of the policy can range from inappropriate clothing items to offensive perfumes and body odor. If a staff member's dress or poor hygiene is an issue, the supervisor should discuss the problem with the staff member in private and should point out the specific areas to be corrected. If the problem persists, supervisors should follow the normal corrective action process.
